






Mission & Objectives

The California Cadet Corps curriculum teaches to four core groups (Military Subjects, Citizenship, Leadership, and Wellness) with 31 standards and 800 lessons that support the California Content Standards in Physical Education, Career Technical Education (Public Service Pathway) Health, English/Language Arts, English Language Development, Math, Science, and Social Science. The California Cadet Corps curriculum is infused with writing, reading, mathematics, fitness/wellness activities, and a variety of career and college preparation components.

Curriculum (A-G Cert)

A-G Certification (College Credit)

The University of California (UC) and the California State University (CSU) systems have established a uniform minimum set of courses required for admission as a freshman. The UC maintains public "a-g" course lists that provide complete information about the high school courses approved for admission to the university.

- · History /Social science ("a")
- English ("b")
- Mathematics ("c")
- · Laboratory science ("d")
- · Language other than English ("e")
- · Visual & performing arts ("f")
- · College-preparatory elective ("g")

Individual California Cadet Corps classes have been approved by the UC system as meeting the "g college-preparatory elective" requirements at several schools. Until a program-wide approval is achieved, high schools with a Cadet Corps Program are encouraged to submit their program for "a-g" certification at the UC Site https://hs-articulation.ucop.edu/agcmp/login#/.

CR 1-2 Safe, Risk Management, Environmental and Cadet Protection Regulation Review

CR 1-2 Safety, Risk Management, Environmental and Cadet Protection

Major revision from prior CR 1-2:

- Updated to adhere to Army Instructions and Policies
- Updated Definitions for Cadet Protection
- Revision of Heat/Cold Training and proper footwear
- Addition of new figures to aid with training and risk assessment matrix
- Guidance for Transgender Cadets, Electronic Communication and Cyberbullying.
- Inclusion of the Cadet Protection Policy

Definitions

- Abuse (taken from CPC 11164)
 - Physical injury of a child by another
 - Sexual Abuse
 - Emotional Abuse
 - Neglect by action of commission or omission.
- Sexual Abuse
 - Cadet/Adult Leader
 - Sexual contact by force
 - Sexual Contact between older/younger cadet
 - Sexual penetration & touching
 - Non-sexual acts: Exposure & Voyeurism

Definitions

- Reasonable Suspicion of Abuse
 - Credible information that abuse occurred
 - Experienced adult leader would agree abuse occurred.
- Hazing & Bullying
 - Both are a form of abuse
 - Appropriate military training is NOT ABUSE
- Boundary Concern
 - When actions are not abuse but are not part of regular "best practices" for training (opportunity to learn)

New Guidance

- Appropriate footwear during training
 - Footwear to be worn
 - No Sandals/Open-Toed shoes (except showers)
- Cyberbullying
 - Texting
 - Social media
 - Other electronic formats
- Transgender Cadets
 - Reasonable accommodations as available (Ca Education Code Sec. 220)

Cadet Protection

- New Chapter 6 in CR 1-2
 - Key Policies
 - Decorum and Fraternization
 - Universal Standards of Practice
 - Training Goals and Intensity
 - Reporting
 - Investigations

- Strictest policy prevails (CACC vs. School)
- All activities will be held to the highest level of professionalism
 - No romantic or sexual activities permitted at activities (PDA)
 - Adult/Cadet relationships are forbidden ALWAYS!
 - Keep in mind for newly transitioned cadets

- Electronic Communication (Adult/Cadet)
 - All electronic communication (text/email) must be professional and specific to CACC Business
 - Consider including a 3rd person on all longer communications ("Rule of 3" concept)
- Proximity of Adult leadership
- Semi-Private Discussions

No cadet "one on one" discussions

- Social Media
 - All posts must be coordinated via CACC S-5
- Personal Care Time
 - No use of electronic recording devices in barracks, latrines, or other areas where undressing occurs
- Required Training
 - Everyone must be trained in Cadet Protection
 - Required review of Cadet Protection at any activity over 2 nights

- Training Intensity and Goals
 - Intensity must meet training goals
 - Must be age appropriate
 - Boundary Concerns
- Reporting Requirements
 - Mandatory Reporters
 - Cadet Reporting
 - False Reporting
 - Non-Retaliation
 - "Reasonable Suspicion of Abuse"

- Investigations
 - CACC will investigate all claims
 - No internal investigation will be conducted if the Military Department or Law Enforcement has an open investigation.

 Complaints identified as boundary concerns will be referred to the chain of command for training.







Office 365 Migration

What is Happening

 Accounts are migrating from Google Services to Microsoft Office 365



Why are we doing this

- Google services are not accessible from some school sites
- Single Sign-On (SSO)
- Google is not Enterprise Ready
- Common document formats

When

- All accounts will be migrated by 22 March 2019
- Commandants can request to be moved prior to the deadline

How

- A new account will be created in Office 365 and credentials sent to the current cadet.org account
- 5 days after the account is created the cadet.org system will be configured to forward email to the new system providing a transition period

How (cont.)

 7 days after the new account is created the old Google account will be locked and a migration of existing email will occur

Responsibilities

- The S-6 will move existing email to the new service
- The end user is responsible for saving Google Drive files, calendar data, etc.

Differences

- Gmail is now Outlook
- Google Drive is OneDrive
- Google Docs is Microsoft Word
- Google Sheets is Microsoft Excel
- Google Slides is Microsoft PowerPoint

- CR 1-5 Cadet Appointments & Promotions
 - Promotion up to C/CPL at discretion of Commandant
 - Defines pathways from C/SNCO to C/Officer
 - Must meet commissioning requirements
 - Limits tenure of C/SNCOs generally to one year
 - Constructive TIG for C/SNCO to board for C/1LT
 - Only testing is at "benchmark" ranks of C/SGT, C/2LT, and C/MAJ
 - All promotions require PTAs which have been restructured to align to new curriculum. New PTA worksheets.
 - Revised TIG timeframes

- CR 1-3 Adult Uniforms (pending publication)
 - UCP ACU can only be worn by those who meet height/weight and only until wear-out date of 30 September 2019.
 - OCP ACU authorized if meet height/weight
 - Changes flag on ACU sleeve from US to California flag
 - Defines CSU and CMU (regardless of height/weight)
 - Allows wearer to cuff ACU sleeves
 - Adds grooming and appearance standards for all uniforms (including beards, tattoos, and piercings)
 - Defines wear of Cadet Class C uniform by adults

- CR 1-3 Adult Uniforms (pending publication)
 - Clarifies footwear and belts for CMU
 - Removes BCTA shoulder cord
 - Authorizes wear of army dress uniforms (with specified distinctions) for those who meet height/weight standards
 - Allows wear of combat patches earned in federal service on ACU uniforms
- CR 2-1 Risk Management as already presented

CR 3 CACC Training

- Major changes to standards contents
- Info on new curriculum
- Lists required CACC knowledge
- New lesson plan & training schedule formats
- CR 3-1 Leadership Training Schools
 - Combines Leadership school, OCS, BNCOC, ANCOC, Specialized Training, BCTA, ACTA, Drill Academies, and CSS into one regulation
 - Adds CLS
 - Updates BCTA content standards
