1. SITUATION:

- a. Name of Event/Operation: Virtual Drill Competition
- b. Dates: 17 April to 1 March 2021
- c. Start and End Times: N/A
- d. Location: Microsoft Teams
- e. Units Participating: All units in the California Cadet Corps.
- f. Participation Requirements: All cadets, in their respective units in the CACC, with parental and commandant permission may participate. All cadets are eligible to participate if registered by the roster due date 9 April 2021.
- g. Training Events Planned: Depending on the division, cadets will be performing individual drill movements, creating original jodies, drill test, teaching a drill manuevor, critiquing a drill video, and assisting in Pass In Review ceremony.

- 2. MISSION:** The California Cadet Corps Virtual Drill Competition will be conducted 17 April 2021 to improve cadet knowledge on drill and ceremonies. With this event, cadets will execute drill in a manner that is not commonly practiced in their respective units due to the pandemic.

3. EXECUTION:

- a. Commander's Intent: To conduct a competitive event that will aim to enhance cadet knowledge on drill. The event will be an excellent way for cadets and their respective units to perform and showcase their proficient drill and ceremonies abilities. This statewide event is intended to raise morale and esprit while competing at home in a safe environment.
- b. Concept of Operations: Virtual Drill Competition will take place virtually via Microsoft Teams or a similar system over a three week period. Cadets will be grouped in either the Junior (Grizzly and Middle school cadets) or the Senior (High school cadets) to compete against each other in several events. The cadets in the Junior Division will perform a series of commanded drill movements live while being graded by Cadet DIs (cadets will have over two weeks to schedule an appropriate time slot to participate in this layer of the competition), create an original jodie, and assess their knowledge in a timed drill test. The cadets in the Senior Division will teach an assigned complicated drill manuevor over video, critique a drill video, assess their knowledge in a timed drill exam, and assist 10th Corps leadership in creating a successful Pass In Review ceremony. Note that each part of the competition will have specific dates of required submission as outlined in the 'Key Dates' section of the WARNO. All submissions will be emailed to the 10th Corps Training and Operations Officer at cadets3@cacadets.org on required submission dates.
- c. Goals:
 - i. All cadets will experience a safe environment with healthy competition.

- ii. All cadets will return to their home units with a better performance in drill and ceremonies.
- d. Objectives:
 - i. No cadets are injured during the event.
 - ii. 100% of cadet participants will showcase their knowledge of drill and ceremonies.
 - iii. The 10th Corps Staff will enhance their collaborative leadership skills to accomplish the event mission.
- e. Leaders & Staff Assignments: The 10th Corps staff will be staffing this event with the assistance of HQCACC staff.
- f. Application Process: Individuals may register themselves with this <https://forms.gle/momaZDCGkxQfLago7>. Cadets must have commandant approval to participate.
- g. Cost: There will be no cost for this event.

 - vi. All Senior Division Instruction Videos Submitted: 24 April 2021
 - vii. All Junior & Senior Division Drill Knowledge Exams Submitted: 25 April 2021
 - viii. Pass In Review Ceremony Released: 1 May 2021
- i. Uniform: All participating Cadets must be in the full Class B uniform which complies with CR 1-8. If Cadets are unable to comply due to inventory restrictions brought upon by COVID-19, competitors are expected to contact the 10th Corps Training and Operations Officer at cadetS3@cacadets.org informing her that uniforms have not been issued at the respective unit.
- j. Awards: Awards given at this competition will be as listed in CR 1-1, chapter 2, paragraphs 2-16 and 2-17.
- k. All participants will receive an email of confirmation that their registration was received and will include the “rules to participate” for the event.
